RESCINDING THE FORMAL COMMUNICATIONS POLICY FOR THE ASSOCIATION**

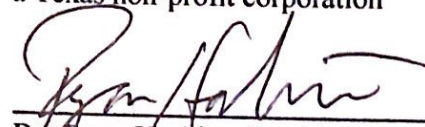
